

ISSUE:

IECP Lease

Currently, the Coalition has two training spaces, the Dale Mabry office and the Professional Development office off US Highway 301. These offices hold up to 20-30 training participants, respectively. These training spaces are used by the ELCHC, partner agencies, and stakeholders both locally and statewide. The number of trainings offered weekly range from three to ten, with an average of six conducted. The lease for the Professional Development office expires 01/31/2017.

Criteria for office space search:

- Office space for staff
- Allows for dedicated space of LiveScan services
- Provide space for provider services to include
 - Lending Library/Resource Center
 - o Business Center
 - Fulfills need for training/meeting space
- Ability to consolidate/collocate admin offices and professional development offices

- Meets all of the office space search criteria
 - Square footage is 11,800
 - Requires no build out.
- Landlord has offered 2 proposals with terms to begin 1/31/17
 - 3 months free rent with extension of all current leases for 1 year.
 - Saves \$54,427 in lease costs in current fiscal year.
 - Obligates the Coalition to stay in current space for 1 add'l year
 - 6 months free rent with extension of all current leases for 2 years.
 - Saves \$108,855 in lease costs in current fiscal year.
 - Obligates the Coalition to stay in current space for 2 add'l years
