

CALL TO ORDER

Noting a quorum had been established, Dr. Shawn Robinson called the meeting to order at 3:03 pm.

Approval of July 19, 2016 regular meeting minutes.

Luke Buzard made a motion to approve the July 19, 2016 Governance Committee meeting minutes. Aakash Patel seconded the motion. The motion carried unanimously.


There were no Action Items.

DISCUSSION ITEMS

Board Member Applications

There was a discussion regarding the current size of the ELCHC Board of Directors. Chair Patel stated that the current Board size consisted of 26 seats, with 3 of the 26 seats open. Chair Patel recommended to reduce the board size to twenty four members. Dr. Robinson noted that a 24 member board would consist of 16 mandatory seats and 8 private sector seats.

Dr. Shawn Robinson made a motion to recommend to the full board that the ELCHC board be reduced to 24 members. Aakash Patel seconded the motion. The motion carried unanimously.



Dr. Robinson recommended that the Governance Committee meet annually to discuss board vacancies and Board applications. The Committee agreed to convene, annually, in April, to discuss vacant board seats and to review board applications.

Board Member Attendance, Involvement, Replacement Procedures, and Evaluation of Board Members

The Committee reviewed and discussed the following samples of board evaluations:

- 1. Board of Directors Full Board Evaluation
- 2. Board of Directors Self Evaluation
- 3. Board Member Evaluation
- 4. Individual Board Member Self-Evaluation

The Committee discussed that an evaluation process would help monitor how the board functions as a group, supports the CEO and organization's mission, and board member engagement and contribution. Dr. Robinson requested that the Committee review the evaluations, with a focus on sample #1 and sample #2, and determine if modifications would be needed before recommending to the full board. The Committee rejected implementing peer evaluations of individual Board members.

Interim Evaluation of New CEO

The Committee reviewed and discussed the Interim Evaluation of the Early Learning Coalition of Hillsborough County (ELCHC) Chief Executive Officer. Dr. Robinson stated that the purpose of the proposed document was to provide an overall rating for the CEO from each board member's perspective of the following questions:

- 1. Overall rating to date of the CEO with 10 being excellent and 1 being poor performance.
- 2. What has the CEO done well since becoming CEO?
- 3. What does the CEO need to improve upon going forward?
- 4. What areas of the Early Learning Coalition staff do you think the CEO should focus on providing leadership?
- 5. What areas of the Early Learning community do you think the CEO should focus on providing leadership?

The Committee agreed to make modifications to question #4 and question #5 on the CEO evaluation and to include the modified version of the evaluation with the February 13, 2017 Board agenda packet for the full board to review.
