I am counting on your commitment and participation as we move toward raising the bar of quality for our programs and our children. It is one of my top goals!





What does the Child Care Licensing Office (CCL), the Early Learning Coalition (ELCHC), and the School Readiness Health and Safety Requirements have in common? Although we are separate entities, Child Care Licensing and the Coalition offices work together more than you might think. Our agencies work closely together on community collaborations, child care enforcement sanctions, and most recently, we have both been tasked with monitoring and enforcing the new School Readiness Health and Safety Requirements established by the Florida Office of Early Learning (OEL).

For those of you that may not know, these new requirements are a result of changes in the federal Child Care Block Development Grant and apply only to providers that receive payment from the Child Care and Development Fund (CCDF). In Florida, CCDF funds are used to provide payments to providers that offer the School Readiness Program.

Locally, the Child Care Licensing Office has been holding workshops for all child care provider's

to inform them of the changes and the anticipated time line for enforcement of these requirements. Although many of the health and safety requirements are currently part of local ordinance, several new regulations have been added and only apply to providers that offer the School Readiness Program.

At this point, you may be asking yourself, "So? What's the relationship then between these agencies?" The answer is simple: the Child Care Licensing Office is responsible monitoring these new requirements and the





Early Learning Coalition is responsible for enforcement. Therefore, if a school readiness provider is out of compliance with the new School Readiness Health and Safety Requirements, it could impact their School Readiness contract.

Now you are asking yourself, "How will these new monitoring and enforcement procedures work?" The Child Care Licensing Office and the Coalition will work collaboratively as follows:

1) One time per year, the Child Care Licensing Office will be conducting an inspection of these new requirements. They will be imbedded into the computer template that CCL already uses and will be done during one of the regular licensing inspections.

2) These inspections will be forwarded

If a school readiness provider is out of compliance with the new School Readiness Health and Safety Requirements, it could impact their School Readiness contract. ))

to the Early Learning Coalition for further action if necessary to ensure the provider corrects any noncompliances. 3) The Child Care Licensing Office
will also investigate any complaint
allegations related to these new
requirements. And, again, the results
will be forwarded to the Coalition who
will determine enforcement actions.

# THE IMPORTANCE OF ATTENDANCE

The Office of Early Learning (OEL) requires that children attending the School Readiness program be signed in/out each and every day. This serves as proof that the child/ren attended your program.

The Early Learning Coalition of Hillsborough County (ELCHC) is required to monitor providers for compliance with this regulation.

The following information is being provided to help providers successfully meet the sign-in/sign-out requirements established by OEL.

The Sign-in/Sign-out sheets must include:

- Name of the provider
- Month/Day/Year
- Name of the child
- Time in; AM or PM
- Time out; AM or PM
- Full signature of parent/guardian or authorized person that picks up the child
  - INITIALS ARE NOT ACCEPTABLE
- School age children picked up at school and transported by the provider must be signed by the provider upon arrival each day. The parent must give written consent to have the provider sign in/out.
- Electronic sign-in/sign-out sheets may be used in lieu of manual sign-in/sign-out sheets. Parent signature must be included attesting to the accuracy of the information listed.
- Correction fluid (such as Wite-Out<sup>™</sup>) is not permitted. If a mistake is made, put a line through and write the correction over it.

Siblings must have individual sign-in/out sheets

ELCHC is unable to authorize reimbursement, or may require a reimbursement adjustment for the following:

- No sign-in/sign-out sheets in use
- Missing sign-in/sign-out sheets
- Discrepancies between attendance rosters and daily sign-in/sign-out sheets
- Parents signing children in and/or out in advance
- Provider signing children in or out when not transporting to/from school
- Provider having a number of children in care that exceeds the licensing capacity.
- Failure to allow ELCHC staff to enter facility while in operation
- Failure to provide ELCHC access to sign-in/sign-out sheets when requested

It is imperative that providers establish procedures to ensure parents and guardians are signing their children in and out properly each and every day.

\*The Sign-in/Sign-out sheets must be retained for a minimum of 5 years. If the contract is terminated, the provider must transfer all the records to the Coalition.

If we create a habit in our families about the importance of maintaining the correct attendance of children at an early age, it will not only help providers maintain a high margin of attendance, but it will also motivate parents to support and make their children's attendance a priority.





# **MPORTANCIA de las ASISTENCIAS**

La Oficina de Educación Temprana (OEL, por sus siglas en inglés) requiere que la asistencia de los niños que participan en el programa de School Readiness sea marcada y firmada todos los días por sus padres/guardianes. Esto sirve como prueba de que los niños asistieron a su programa. El Early Coalition of Hillsborough County (ELCHC) está obligado a verificar que los proveedores cumplan con este reglamento.

La siguiente información les ayudará a cumplir satisfactoriamente con los requisitos de asistencia establecidos por OEL.

Las hojas de ENTRADA / SALIDA (Sign In/Out Sheets) deben incluir:

- Nombre del proveedor
- Mes/Día/Año
- Nombre completo del niño/a .
- Hora de llegada, incluyendo AM o PM
- Hora de salida, incluyendo AM o PM .
- Firma completa del padre o persona autorizada que . recoge al niño/a
  - NO SE ACEPTAN INICIALES
- Las hojas de entrada/salida de niños de edad escolar que son recogidos en la escuela y transportados por el proveedor deben ser firmadas por el proveedor a la llegada y salida cada día.
- El padre debe dar su consentimiento por escrito para que el proveedor pueda firmar las hojas de entrada/o salida del niño/a.
- Se pueden utilizar hojas electrónicas de entrada / salida en lugar de las hojas de entrada / salida manuales. Se requiere la firma de los padres para certificar esta información.
- No se permite usar corrector (Wite-Out). Si se hace un error, cruce con una línea y escriba la corrección por

encima de ella.

• Los hermanos deben tener hojas de entrada/salida individuales.

ELCHC no puede autorizar reembolso, o podría requerir un ajuste de reembolso por lo siguiente:

- Falta de hojas de entrada / salida
- Discrepancias en el registro de asistencia y las hojas de entrada/salida
- Padres que firman la entrada/salida de sus niños por adelantado
- El proveedor firma la salida de los niños
- El proveedor tiene un número de niños que excede la capacidad de su licencia
- No permitir acceso al personal del ELCHC al programa durante horas de operación
- No proveer acceso al personal del ELCHC a las hojas de entrada/salida cuando se solicitan

Es imperante que los proveedores establezcan un procedimiento para asegurar que los padres/guardianes firmen las hojas de entrada/salida de sus niños correctamente todos los días.

\*Las hojas de entrada/salida tienen que ser retenidas por un mínimo de cinco (5) años. Si el contrato es terminado, el proveedor debe devolver todos los registros de School Readiness a la Coalición.

Si creamos un hábito en nuestras familias sobre la importancia de mantener la asistencia de los niños correctamente desde una temprana edad, no solo ayudará a los proveedores a tener un margen de asistencia alto, también motivará a los padres a mantener y hacer de la asistencia de sus niños una prioridad. 🕵

# STEPS TO MAKE PARENT NIGHT A PIECE OF CAKE

successful parent night sets the tone for building positive relationships with the families that you serve. It increases parent morale. It builds the foundation that helps us define quality childcare. It helps parents become vested in the learning process, and allows them to see the value of their return on investment in their child's education.

### INGREDIENTS

- 1 GROUP OF PARENTS
- 1 BUDGET
- 8 WEEKS OF PLANNING
- 1 EXCITING THEME
- 1-2 ENGAGING ACTIVITIES
- 4 FOOD ITEMS
- 1-4 STAFF/VOLUNTEERS

MEASURE

Plan over an 8-week period

Parent night dates should be picked and budgeted • for during your yearly planning sessions. Budgets can be built through fundraising events, grants, scholarship programs, and donations. Some of the possible items to budget for would be materials, food, employee overtime, and advertising. Having a parent night on a quarterly basis is just abou the right dosage to keep your parents engaged. Preplanning is easier when you can answer the Who, What, When, and Why questions.

Who are you trying to attract to this event? Parents and

What are they going to do? Complete activities to help them become familiar with the reading, language, and writing curriculum.

Where are you going to host your parent night? At your center or home.

When choosing a date and time, pick a date and time that most families would be able to attend. Weekday evenings after pick up usually work best.

Why are you doing this? To increase literacy awareness and increase reading opportunities at home.







Food

Since many parent nights take place in the evening, providing food that help parents stay alert and increase cognitive functions should always be included in the menu. The right foods can help stimulate your brain. If you are working within a budget you can ask for food donations from local businesses. You can also host a potluck and have parents bring food. Finally, you can use funds from your budget that you created during your preplanning stage. Some examples of the best food to encourage blood flow to the brain are:

- Vegetable trays with dark green veggies such as broccoli. People who eat broccoli have better memory retention.
- Fruit trays with Blackberries and cherries which are loaded with antioxidants and help blood circulation.
- Tuna salad and crackers have omega-3 fatty acids which help keep brain cells active and healthy.
- Walnuts increase better memory and brain functioning.

The theme should be mainstream and include current topics that are trending such as S.T.E.M., early literacy, etc. Group activities are a great way for parents to get to know each other. They also help parents develop a sense of working in a community. Group activities help parents share diverse perspectives and pool their skills together. It is important to provide resources and handouts that aid in continuous learning at home. Some examples of group activities for an early literacy night are:

- Icebreakers getting to know each other and the providers/staff
- Games rhyming, matching, sounding out
- Role playing opportunity for provider to mentor parent/child interactions
- Group discussion parents build on each other's ideas and skills
- Materials alphabet blocks, books, puzzles, and flash cards

### HEALTH AND SAFETY

INSPECTIONS Whats all this talk about



Health & Safety inspections and should you care? YES! Federal legislation re authorizing the Child Care Development Fund (CCDF) included new health and safety requirements for child care providers that receive CCDF funding. In Florida, that means that ALL child care providers offering the School Readiness Program must have at least one inspection each year. Those inspections began in mid-November 2016. All elements of Florida's Health and Safety Checklists and Inspections go into effect July 1, 2017. Be sure to read the article on page 6 of this issue for some clarity on this important requirement!

### PROFESSIONAL DEVELOPMENT REGISTRY

The registry allows early learning professionals to track

training they have completed and record certificates they receive. Florida's statewide registry helps attract, retain and develop a well-qualified early care and education workforce. The system assists practitioners to assess current quantifications, identify education resources and support, and plan a career pathway. The registry will also allow policymakers to analyze barriers to access, support needed for continued career advancement and program-wide improvements for early learning programs. To register with the registry go


