Notification of Absences of At Risk Children

For any At Risk child age birth - 5 (not in school) enrolled in your care who is under protective services/"Funding" coded "BG1" on the Child Care Certificate:

*If you see the following eligibility codes on the child care certificate, you are required to report: 11, 11D, 13, 14R, IN, OUT

School Readiness providers are contractually obligated to report:

ANY **unexcused absence of a BG1 child by the end of the business day following the unexcused absence

OR

Seven (7) consecutive excused absences of a BG1 child by the end of the seventh consecutive excused absence.
