

CALL TO ORDER

Noting a quorum had been established, Dr. Shawn Robinson called the meeting to order at 9:11 am.

DISCUSSION ITEMS

Budget Report

Steve Costner, ELCHC Chief Financial Officer, reported on the School Readiness budget, which included subcontracts with the School District of Hillsborough County, Child Care Licensing, and Early Childhood Council, the Voluntary Pre-Kindergarten budget, which included a subcontract with Early Childhood Council, and the Coalition Operating budget.

Mr. Costner stated that he was projecting a \$500,000 surplus in School Readiness funds, and that a modified model to help forecast utilization would be used moving forward in FY 2018-2019. Mr. Costner added that there was a reduction in expenditures than previously reported at the March budget workshop, due to a reduction in staff and bringing health benefits in-house. The Committee requested a comparison of expenditures between this fiscal year (17-18) and the next fiscal year (18-19).

There was a discussion regarding provider reimbursement rates. Mr. Gillette stated that it would be worthwhile to conduct a study on the reimbursement rates and make a recommendation to the board.



ISSUE: Execute School Readiness Funding Match Contract with Children's

Board of Hillsborough County

FISCAL IMPACT: Up to \$1,723,238

FUNDING SOURCE: Children's Board of Hillsborough County

RECOMMENDED ACTION: Authorize staff to execute a contract with Children's Board of

Hillsborough County in the amount up to \$1,723,238 for the period

October 1, 2018 to September 30, 2019.

NARRATIVE:

The Coalition is required by the Office of Early Learning to secure a 6% local match for School Readiness funds and a 1:1 match for the Child Care Executive Partnership (CCEP) funds used to serve low-income working families. Historically, the Children's Board of Hillsborough County (CBHC) and others have allocated funds to meet these requirements.

The CBHC funds support the required 6% match for funds used to serve low-income working families and a portion of the 1:1 match required by the CCEP. In addition, the CBHC has allocated funds for afterschool and summer programs for children whose families who receive services through Metropolitan Ministries.

The Coalition has submitted the CBHC contract materials and anticipate the contract to be executed effective October 1, 2018. Once the contract with CBHC is executed, funds will be available for the period October 1, 2018 to September 30, 2019. This contract is contingent upon approval at the CBHC Board meeting on September 27, 2018. All the funds mentioned are used solely to provide direct child care services.

Authorize staff to execute a contract with the Children's Board of Hillsborough County in the amount up to \$1,723,238 for the period October 1, 2018 to September 30, 2019 contingent upon CBHC of Directors' approval.

ISSUE: Execute School Readiness Match Contract with The School Board of

FUNDING SOURCE: Children's Board of Hillsborough County

RECOMMENDED ACTION: Authorize staff to execute a contract amendment with The School Board

of Hillsborough County in the amount up to \$1,723,238 for the period

October 1, 2018 to June 30, 2019.

NARRATIVE:

Historically, the Children's Board of Hillsborough County (CBHC) and others have allocated funds to support the 1:1 match required by the Child Care Executive Partnership (CCEP) used to serve low-income working families. The Coalition, with Board approval, will continue to contract with the School Board of Hillsborough County consistent with the funding earmarks established by the CBHC to distribute the funding to contracted child care providers serving eligible children to support the CCEP match requirements.

The CBHC funds support a portion of the 1:1 match required by the CCEP. In addition, the CBHC has allocated funds for afterschool and summer programs for children whose families who receive services through Metropolitan Ministries.

Staff is requesting authorization to execute a contract with The School Board of Hillsborough County in the amount up to \$1,723,238 for the period October 1, 2018 to June 30, 2019 contingent upon contract execution from CBHC.

ACTION ITEM V.D.

ISSUE: Accept \$90,000 from United Way Suncoast to provide child care

funding assistance for families displaced from 2017 hurricanes

FISCAL IMPACT: Up to \$90,000

FUNDING SOURCE: United Way Suncoast

RECOMMENDED ACTION: Accept \$90,000 from United Way Suncoast and authorize staff to

provide child care funding assistance to qualifying families in the amount up to \$90,000 for the period beginning August 1, 2018 until

funds are expended.

NARRATIVE:

Coalition staff were offered an opportunity from United Way Suncoast to assist families displaced by the 2017 hurricanes with child care assistance using existing School Readiness guidelines. United Way Suncoast agreed to provide \$90,000 to seed the efforts with an understanding additional funds would be forthcoming from the Community Foundation of Tampa Bay.

Staff is requesting authorization to provide services to assist eligible families to secure child care using the \$90,000 of United Way Suncoast funding.
