Chair Patel called for a motion to approve the Consent Agenda. Dr. Stephie Holmquist Johnson made a motion to approve the Consent Agenda. Dr. Shawn Robinson made a second. The motion carried unanimously.

#### **ACTION ITEMS**

A. Execute School Readiness Funding Match Contract with Children's Board of Hillsborough County (CBHC)

Mr. Gordon Gillette requested full Board approval of executing the contract with CBHC. The CBHC School Readiness Match contract supports childcare to serve low-to-moderate income working families.

Chair Patel called for a motion to authorize staff to execute a contract with the Children's Board of Hillsborough County in the amount of up to \$775,770. Dr. Shawn Robinson made a motion. Dustin Portillo made a second. The motion carried unanimously. Kelley Parris abstained due to a conflict of interest.

**B.** Execute Contract with Hillsborough County Board of County Commissioners (BOCC) Mr. Gillette requested full Board approval to execute the renewal contract with BOCC.

Chair Patel called for a motion to authorize staff to enter into a contract with Hillsborough County BOCC in the amount of up to \$276,000. Dr. Shawn Robinson made a motion. Candy Olson made a second. The motion carried unanimously. Gwen Myers abstained due to a conflict of interest.

C. Execute Community Development Block Grant (CDBG) contract with City of Tampa Mr. Gillette requested full Board approval to execute a contract with the City of Tampa. The funds will be used to benefit low-to-moderate income families.

Chair Patel called for a motion to authorize staff to enter into a contract with the City of Tampa in the amount of up to \$100,000. Dr. Stephie Holmquist Johnson made a motion. Candy Olson made a second. The motion carried unanimously.

D. Approve allocation of funds to Discount Office Furniture

Gary Meyer, Chief Financial Officer, reported that the allocation of \$140,000 will be used to purchase infant and toddler materials and furnishing, servicing up to 12 School Readiness Program centers and Family Child Care Homes.

Chair Patel called for a motion to approve the allocation of funds in the amount of up to \$140,000 to Discount Officer Furniture. Dr. Shawn Robinson made a motion. Dr. Lise Fox made a second. The motion carried unanimously.

Gary Meyer, Chief Financial Officer, reviewed the financial statements updates through May 31, 2021, and full-year forecast, including updates through June 30, 2021.

#### **CEO REPORT**

#### **Revised FY 21-22 CEO Strategic Objectives**

Mr. Gillette informed the Board that the FY 21-22 CEO Strategic Objectives were revised to align with the Coalition's Access, Education, and Quality pillars.

Candy Olson requested to include quantifiable measurements to the CEO Strategic Objectives.

#### **COVID-19 Impact on Childcare and Funding**

Mr. Gillette reported three hundred and thirty-five (335) positive cases of COVID-19 in childcare provider sites in August. Fifty-three (53) childcare provider sites were closed due to COVID-19.

#### **Division of Early Learning Leadership Updates**

Mr. Gillette reported that DEL announced former Department of Education General Counsel Matt Mears as the Chancellor of DEL.

#### **Division of Early Learning Accountability Monitoring**

Mr. Gillette reported on the FY 21-22 Accountability Monitoring conducted by the Division of Early Learning (DEL). The accountability monitoring is a full desk review of activities and transactions performed by the ELCHC. As part of the monitoring, a childcare provider survey was released. Mr. Gillette informed the Board that the Coalition received a 91% favorable to somewhat favorable customer service level.

The was further discussion on the provider survey.

#### **CLASS Observations**

Mr. Gillette reported that the Coalition completed five hundred and eighty-five (585) CLASS Observations in FY 20-21.

#### **Professional Development**

Mr. Gillette provided an update on the new hire stipends and INCENTIVE\$.

#### Hillsborough Early Learning Network Partnership

Mr. Gillette provided an update on the partnership with the University of Florida Lastinger Center for Learning.

#### 3-5 Initiative

Mr. Gillette provided an update on the 3-5 Initiative.

#### **Early Childhood Task Force**

Mr. Gillette announced that the Coalition,in partnership with the Hillsborough County Public Schools ,will focus on increasing early childhood education in public schools.

#### **Ransomware Attack**

Mr. Gillette reported that on July 30, 2021, the Coalition informed the full Board of Directors of technology challenges that started on July 29, 2021. After further investigation, it was identified that a ransomware attack had occurred. The MIP Fund Accounting System was affected; the system is used to pay childcare providers. Mr. Gillette noted that the Coalition is working with the Federal Bureau of Investigation (FBI), legal counsel, MIP, and Roebuck. Mr. Gillette stated that there were no delays in payment to childcare providers.

Mr. Gillette stated that on August 26, 2021, an official press release addressing the ransomware attack would be made public. The Coalition will formally disclose the information to any affected parties (excluding families- as no family data was impacted).

There was further discussion on the Coalition's communication efforts to affected parties.

#### **DISCUSSION ITEMS**

Alison Fraga, Chief Development Officer, informed the Board of the upcoming 2<sup>nd</sup> Annual Family Holiday Event – Trains, Toys & Tidings that will take place on December 4, 2021, at the Coalition's

central office location. In addition, Mrs. Fraga announced two sponsors as of August 23, 2021, Publix Charites, and Florida Blue.

     Delivery and Efficiency Committee.
  - Section 2 (b) Updated language on the role of the Finance Committee and membership.
  - Section 3 Added Special Committees, removed Advisory Committees.
  - Section 5 Added that members who attend Committee meetings by phone or other electronic means could be counted towards a quorum.
- The "Office of Early Learning" was updated to the "Florida Department of Education Division of Early Learning" throughout the Bylaws.

#### **BYLAWS**

#### OF

#### THE HILLSBOROUGH COUNTY SCHOOL READINESS COALITION, INC.

#### **ARTICLE I**

#### **Organization**

- Section 1. Name. The name of this Corporation is Hillsborough County School Readiness, Coalition Inc. (the "Corporation") and shall conduct business as The Early Learning Coalition of Hillsborough County as registered pursuant to the Fictitious Name Act, 865.09 F.S. with the Division of Corporations, Florida Department of State.
- Section 2. <u>Objectives</u>. The Corporation has been formed to coordinate and improve the quality and delivery of school readiness, voluntary pre-kindergarten and out-of-school time services for the children and families of Hillsborough County, Florida.
- Section 3. <u>Principal Office</u>. The principal office of the Corporation shall be fixed and located by the Board of Directors of the Corporation at any place within the County of Hillsborough, State of Florida. The Board of Directors is hereby granted full power and authority to change said principal office from one location to another in the County of Hillsborough.
- Section 4. <u>Members</u>. The Corporation shall have no "members" as that term is defined in 617.01401(12) Florida Statutes.
- Section 5. <u>Government-in-the-Sunshine Law</u>. The Corporation is committed to ensuring that the deliberations of its Board of Directors are conducted openly and the actions of the Board are taken openly in accordance with the Government-in-the Sunshine Law, Chapter 286 of the Florida Statues. Accordingly in the event of a conflict between a provision of these Bylaws and a section of the Government-in-the-Sunshine Law, the Government-in-the-Sunshine Law shall control.

#### **ARTICLE II**

#### **BOARD OF DIRECTORS**

Section 1. <u>Powers</u>. Subject to the limitation of the Articles of Incorporation and other provisions of these Bylaws, and the laws of the State of Florida, all corporate

powers shall be exercised by, or under the authority of, and the business and affairs of the Corporation shall be controlled by the Board of Directors (sometimes referred to herein as the "Board").

#### Section 2. Membership, Number, Class, Voting Rights, Selection and Terms of Office.

(a) <u>Membership, Number and Classes</u>: The Board of Directors shall number least fifteen (15) but not more than thirty (30) and shall be divided into three (3) classes: Appointed Directors, Designated Directors, and Elected Directors.

#### (b) Selection and Terms of Office:

- Appointed Directors shall serve as directors as long as they hold the offices so designated. Appointed Directors may serve a maximum of two consecutive terms
- Designated Directors shall serve as directors as long as they hold the offices so designated.
- Elected Directors shall serve four (4) year terms. Elected Directors are eligible for re-election. However, no elected Director may serve more than two consecutive four-year terms.
- (c) Appointed Director Class: The authorized number of Appointed Directors shall be three (3). All vacancies in the class of Appointed Directors, including, without limitation, vacancies caused by expiration of term, resignation or removal, shall be filled by the Governor of the State of Florida as follows:
  - 1) Chair appointed by the Governor
  - 2) Two (2) private sector business members appointed by the Governor In the absence of a governor-appointed chair, the Commissioner of Education may appoint an interim chair from the current early learning coalition board membership. (F.S. 1002.83). In the absence of an appointed interim, the Vice-Chair shall serve as interim Chair.
- (d) <u>Designated Director Class</u>: Designated Directors shall number twelve (12) and shall include the following:

- 1. Department of Children and Families child care regulation representative or an agency head of a local licensing agency as defined in s. 402.302, where applicable.
- 2. District superintendent of schools or his or her permanent designee who is authorized to make decisions on behalf of the district.
- 3. A local workforce development board executive director or his or her permanent designee.
- 4. County health department director or his or her designee.
- 5. A children's services council or juvenile welfare board chair or executive director, if applicable.
- 6. An agency head of a local licensing agency as defined in s. <u>402.302</u>, where applicable.
- 7. A president of a Florida College System institution or his or her permanent designee.
- 8. One Member appointed by the board of county commissioners or the governing board of a municipality.
- 9. A Head Start director.
- 10. A representative of private for- profit child care providers, including private for-profit family day care homes.
- 11. Representative of faith-based child care providers.
- 12. Representative of programs for children with disabilities under the Federal Individuals with Disabilities Education Act.
- (e) Elected Director Class: Elected Directors shall shall not exceed fifteen (15). All vacancies in this class of Elected Directors, including, without limitation, vacancies caused by expiration of term, resignation or removal, shall be elected by a majority of the Board then in office. The Elected Directors shall at all times be representatives of private sector business, either for-profit or nonprofit, who do not have, nor whose relatives as defined in s.112.3143 have, a substantial financial interest in the design or delivery of Voluntary Prekindergarten Education programs, School Readiness programs, or out-of-school-time programs.

#### Section 3. <u>Vacancies.</u>

(a) A vacancy or vacancies in the Board shall be deemed to exist (i) in case of the death, resignation, or removal of any director or (ii) if the authorized number of directors is increased.

- (b) Any director may resign effective upon giving written notice to the Chair, the Chief Executive Officer, the Secretary, or the Board, unless the notice specifies a later time for the effectiveness of such resignation. If a director resigns by giving notice specifying that such resignation shall be effective at a future time, a successor may be elected or designated before such time to take office when the resignation becomes effective.
- (c) No reduction in the number of directors shall have the effect of removing any director prior to the expiration of his or her term of office.
- (d) When a vacancy occurs in an appointed position, the coalition must advertise the vacancy.
- Section 4. <u>Removal of Directors.</u> Any member of the Board of this Corporation may be removed from office, with or without cause, by the person or persons authorized to elect or designate the director in Section 2 (d) (e) of this Article II.

#### ARTICLE III

#### Meetings of the Board of Directors

- Section 1. <u>Place of and Public Access to Meetings.</u> All meetings of the Board of Directors shall be held at the principal business office of the Corporation or at such other place within the County of Hillsborough as may be designated from time to time by resolution of the Board of Directors, or in the notice of said meeting. All meetings of the Board of Directors shall be open and public, and all persons shall be permitted to attend any meeting of the Board.
- Section 2. <u>Annual Meeting</u>. The annual meeting of the Board of Directors shall be the regular meeting of the Board held during the fourth quarter of the fiscal year. The officers of the Corporation shall be elected at this meeting.
- Section 3. Regular Meetings. The Board of Directors shall meet on the date established by the Board of Directors by resolution. The Board shall meet at least four (4) times during each fiscal year.
- Section 4 <u>Special Meetings</u>. Special meetings of the Board of Directors for any purpose or purposes shall be called at any time by the Chair of the Board, the Chief Executive Officer, the Secretary, or by any two (2) directors of the Corporation. Special meetings of the Board of Directors shall be held upon two (2) calendar days' prior notice. Notice may be given

orally, by first-class mail, by facsimile, electronic mail, or other electronic means, or by personal delivery to each director at such director's address as is shown upon the records of the Corporation for purposes of notice. Notice by mail shall be deemed to have been given at the time a written notice is deposited in the United States mail, postage prepaid. Any other written notice shall be deemed to have been given at the time it is personally delivered to the recipient or is delivered to a common carrier for transmission to the recipient. Oral notice shall be deemed to have been given at the time it is communicated, in person or by telephone, to the recipient or to a person at the office of the recipient who the person giving notice has reason to believe will promptly communicate it to the recipient. A notice or waiver of notice shall specify the purpose of any special meeting of the Board of Directors.

Section 5. Action at a Meeting; Quorum and Required Vote. Presence of a majority of Directors at a meeting of the Board of Directors constitutes a quorum for the transaction of business. A Director may send a representative to a meeting, but that representative does not count towards the quorum requirement and does not have voting privileges. Every act or decision done or made by a majority of the director's present at a meeting duly held at which a quorum is present shall be regarded as the act of the Board of Directors. Board members attending by phone or other electronic means may be counted towards the quorum requirement.

Section 6. <u>Rules of Procedure</u>. All meetings of the Board of Directors shall be conducted in accordance with Robert's Rules of Order. Nothing in Robert's Rules of Order shall supersede any right or requirement of the Articles of Incorporation or these Bylaws.

Section 7. <u>Fees and Compensation</u>. The Board of Directors shall serve without compensation for their services as directors; however, the Appointed Board Chair or Appointed Vice-Chair may be reimbursed for travel and related expenses to attend State meetings per guidance from the Florida Department of Education Division of Early Learning.

Section 8. Each Board member is subject to Florida Statutes ss. <u>112.313</u>, <u>112.3135</u>, and <u>112.3143</u>. For purposes of s. <u>112.3143</u>(3)(a), each voting board member is a local public officer who must abstain from voting when a voting conflict exists.

# ARTICLE IV Officers

Section 1. Officers. The officers of the Corporation shall be a Chair of the Board, a Vice Chair, a Secretary, and a Treasurer and other officers as the Board of Directors may elect. All Page **8** of **16** 

officers of the Corporation must also be directors of the Corporation. The removal or resignation of a director who is an officer of the Corporation shall be deemed a resignation by such person from all offices held.

- Section 2. <u>Nomination and Election</u>. The officers of the Corporation, other than the Chair shall be elected annually by the Board of Directors at its annual meeting. Each officer so elected shall hold office for a one-year term or until he or she shall resign, shall be removed or otherwise disqualified to serve. At any regular or special meetings of the Board of Directors, the Board of Directors may fill a vacancy caused by the death, resignation, removal or disqualification of any officer. Officers may be elected to serve additional terms at the discretion of the Board.
- Section 3. Removal and Resignation. Any officer may be removed, either with or without cause, by the Board of Directors, at any regular or special meeting thereof. Any officer may resign at any time by giving written notice to the Chair of the Board, the Chief Executive Officer, or the Secretary of the Corporation. Any such resignation shall take effect at the date of the receipt of such notice or at any later date specified therein; and unless otherwise specified therein, the acceptance of such resignation shall not be necessary to make it effective.
- Section 4. <u>Chair of the Board</u>. The Chair of the Board shall preside at all meetings of the Board of Directors and exercise and perform such other powers and duties as may be from time to time assigned to the Chair by the Board of Directors or prescribed by the Bylaws.
- Section 5. <u>Vice Chair</u>. In the absence of the Chair, the Vice Chair will exercise the duties of the Chair and shall perform such other duties as may be from time to time require by the Chair or by the Board of Directors.
- Section 6. <u>Chief Executive Officer</u>. The Chief Executive Officer, subject to the control of the Board of Directors, shall have general supervision, direction and control of the business and affairs of the Corporation and shall have the general powers and duties of management usually vested in the office of the Chief Executive Officer of a corporation. The Chief Executive Officer shall have the necessary authority and responsibility to operate the Corporation and all of its activities and departments, subject only to such policies as may be issued by the Board of Directors or any of its Committees to which it has delegated powers for such action. The Chief Executive Officer shall act as a duly authorized representative of

the Board of Directors in all matters in which the Board of Directors has not formally designated some other person to act.

Section 7. Secretary. The Secretary shall record or cause to be recorded, and shall keep or cause to be kept, at the principal business office or such other place as the Board of Directors may order, an electronic copy of minutes that include actions taken at all meetings of the Board, with the time and place of holding, whether regular or special, and if special, how authorized, the notice thereof given and the names of those present at Board meetings. The Secretary shall give, or cause to be given, notice of all the meetings of the Board of Directors required by the Bylaws or by law to be given, and shall have such other powers to perform such other duties as may be prescribed by the Board of Directors or by the Bylaws.

Section 8. <u>Treasurer</u>. The Treasurer shall keep and maintain, or cause to be maintained, adequate and correct accounts of the properties and business transaction of the Corporation, including accounts of its assets, liabilities, receipts, disbursements, gains, and losses. The Treasurer shall submit a statement of accounts on a quarterly basis at meetings of the Board of Directors and shall make reports as the Board of Directors may require. The Treasurer shall cause to be deposited or shall cause to be disbursed in accordance with procedures approved by the Board of Directors all monies and other valuables in the name and to the credit of the Corporation and shall have such other powers to perform such other duties as may be prescribed by the Board of Directors or by the Bylaws.

# ARTICLE V Committees

#### Section 1. <u>Committees</u>.

- (a) The Board of Directors may, by resolution adopted by a majority of the Directors then in office, provided that a quorum is present, establish one or more committees. Members of all committees shall be appointed by the Board of Directors. Committees are of two kinds, those having legal authority to act for the Corporation, known as Standing Committees of the Board, and Special Committees, that do not have legal authority. Members of all committees shall serve at the pleasure of the Board.
- (b) The Board of Directors shall have the power to prescribe the manner in which proceedings of any committee shall be conducted. In the absence of any such prescription, such committee shall have the power to prescribe the manner in which its proceedings shall be conducted. Unless these Bylaws, The Board or

such committee shall otherwise provide, the regular and special meetings and other actions of any committee shall be governed by the provisions of Article V applicable to meetings and actions of the Board of Directors. Each committee of the Board shall keep regular minutes of its proceedings and shall report the same to the Board from time to time, as the Board of Directors may require.

Section 2. <u>Standing Committees of the Board</u>. Only directors may be appointed to Standing committees of the Board. Each committee of the Board shall consist of three (3) or more Directors. The Board may designate one or more Directors as alternate members of any such committee, who may replace any absent member at any meeting of the committee. Standing Committees of the Board include the Executive Committee, Finance Committee, Governance Committee and Service Delivery & Efficiency Committee

Executive Committee: The Executive Committee is made up of the Officers of the Board, Chairs of the Standing Committees of the Board. The Executive Committee may act on behalf of the Board between regular Board meetings except they are not permitted to do the following: amend the articles or bylaws; dissolve the corporation; dismiss or elect new Board members or officers; hire or fire the chief executive; enter into major contracts or sue another entity; change a board approved budget in excess of their existing authority; or adopt or eliminate major programs.

<u>Finance Committee</u>: The role of the Finance Committee is to recommend policies that protect the organization's assets, review the annual budget, monitor financial reports prepared by staff, oversee the annual audit(s), govern the management of investments, make recommendations to the full Board for approval, and work to make sure the organization is in good financial health. Membership shall consist of board members appointed by the Board Chair with at least one (1) member being a financial expert (CPA or related certification, current/former CEO or CFO).

Governance Committee: The Governance Committee has the responsibility of recommending action items to the full Board that relate to: Board By-Laws, Board policies, Board meeting procedures and protocols, Board member nominations, Board officer nominations, Board leadership structure, the Chief Executive Officer evaluation process-each early learning coalition shall complete an annual evaluation of the early learning coalition's executive director or chief executive office on forms adopted by DEL, and Chief Executive Officer communication with Board and Florida Department of Education Division of Early Learning (DEL). Membership shall consist of board members appointed by the Board Chair.

Service Delivery & Efficiency Committee: Membership shall consist of Board appointed by the Board Chair. The Committee has the responsibility of reviewing, analyzing, and overseeing Coalition programs and recommending action items to the full Board that relate to: Coalition expenditures related to services and quality, program evaluation and improvement, contract compliance, and provider effectiveness. The Committee shall collect data, information, and comments from providers in support of its mission to provide supportive and quality services as well as disseminate such information to the full Board as is relevant.

Section 3. Special Committees. The Board of Directors may form one or more committees, in addition to the Standing Committees of the Board. from time to time, to assist in the gathering of information, performance of tasks, or other duties related to the general performance and attainment of the purposes of the Corporation. Each such committee shall establish its rules for the conduct of its affairs, shall establish its duties and purposes, and shall perform such other duties as the Board may prescribe from time to time. Each of these committees will include a Committee Chair or Co-chair. The role of any special committee is to bring forth recommendations to the full Board for consideration.

Section 4. <u>Term of Office</u>. The chair and each member of a standing committee shall serve until the next election of directors and until his or her successor is appointed, or until such committee is terminated, or until he or she is removed, resigns or otherwise ceases to quality as a member of the committee. The chair and each member of a special committee shall serve for the life of the committee unless they are removed, resign, or cease to qualify as members of such committee.

Section 5. Quorum Meetings. Each committee shall meet as often as necessary to perform its duties, at such times and places as directed by its chairman or by the Board of Directors and in compliance with the Government-in-the Sunshine Law. A majority of the members of a committee shall constitute a quorum. Members attending by phone or other electronic means may be counted towards the quorum requirement. The act of a majority of the members present at the meeting at which a quorum is present shall be the act of the committee. Each committee of the Board shall keep accurate minutes of its meetings, the chair designating a secretary of the committee for this purpose and shall make periodic reports and recommendation to the Board of Directors.

Section 6. <u>Vacancies</u>. Vacancies on any committee may be filled for the unexpired portion of the term in the same manner as provided in the case of original appointments.

Section 7. <u>Conflict of Interest</u>. The Board, through a committee designated for that purpose, shall require not less frequently than once a year statements from each director setting forth all business and other affiliations which relate in any way to the business of the Corporation.

#### **ARTICLE VI**

#### Indemnification and Insurance

- Section 1. Right of Indemnity. To the fullest extent permitted by law, this Corporation shall indemnify its directors, officers, employees, and agents, including persons formerly occupying any such positions, against all expenses, judgments, fines, settlements, and other amounts actually and reasonably incurred by them in connection with any proceedings whether civil, criminal, administrative or investigative, and including an action by or in the right of the Corporation, by reason of the fact that the person is or was acting in such capacity.
- Section 2. <u>Approval of Indemnity</u>. On written request to the Board by any person seeking indemnification, the Board shall promptly determine whether the applicable standard of conduct has been met and, if so, the Board shall authorize indemnification.
- Section 3. <u>Insurance</u>. The Board of Directors may adopt a resolution authorizing the purchase and maintenance of insurance on behalf of any agent of the Corporation against any liability asserted against or incurred by the agent in such capacity or arising out of the agent's status as such, whether or not the Corporation would have the power to indemnify the agent against that liability under the provision of this Article.

#### **ARTICLE VII**

#### **General Provisions**

- Section 1. <u>Voting Shares</u>. The Corporation may vote any and all shares or memberships held by it in any other corporation by such officer, agent or proxy as the Board of Directors may appoint, or, in the absence of any such appointment, by the Chair, the Chief Executive Officer, the Secretary or the Treasurer. In such case, such officers or any of them similarly may appoint a proxy to vote said shares.
- Section 2. <u>Check, Drafts, Etc.</u> All checks, drafts or other orders for payment of money, notes or other evidences of indebtedness, issued in the name of or payable to the

Corporation, and any and all securities owned or held by the Corporation requiring signatures for transfer, shall be signed or endorsed by such person or persons and in such manner as from time to time, shall be determined by the Board of Directors.

- Section 3. <u>Inspection of Corporate Records</u>. The Corporation shall keep at its principal business office, the originals or copies of its Articles of Incorporation and Bylaws, as amended or otherwise altered to date, certified by its Secretary; written minutes of the meetings of its Board of Directors, and any committees of the Board; its books and records of account; and all other books, records and documents of the Corporation.
- Section 4. Endorsement of Documents; Contracts. Any note, mortgage, evidence of indebtedness, contract, conveyance or other instruments in writing, and any assignment or endorsement thereof executed or entered into between the Corporation and any other person, when signed by the Chair, the Chief Executive Officer, the Secretary, or the Treasurer, shall be valid and binding on the Corporation in the absence of actual knowledge on the part of the other person that the signing officer(s) had no authority to execute the same. Any such instrument may be signed by any other officers, agents or employees and in such manner as shall from time to time be determined by the Board of Directors and, unless so authorized by the Board of Directors no other officer, agent or employee shall have any power or authority to bind the Corporation by any contract or engagement or to pledge its credit or to render it liable for any purpose or amount.
- Section 5. <u>Conflict of Interest and Related Party Transactions</u>. The Corporation, through its Board of Directors, shall promulgate, from time to time a written conflict of interest and related party transaction policies, according to the current law then in effect, to be adhered to by its offices, directors, employees, and agents, and which includes guidelines for the resolution of existing or apparent conflicts of interest and/or related party transactions.
- Section 6. <u>Dissolution</u>. The Corporation may be dissolved only with authorization by its Board of Directors given at a special meeting called for that purpose and with subsequent approval by a two-thirds (2/3) vote. Upon dissolution or termination of the Corporation, all remaining assets, after payment in full of all its debts, obligations, and necessary final expenses, or after the making of adequate provision therefore, shall be distributed to organizations operated exclusively for charitable, and/or educational purposes as shall at the time qualify as an exempt organization under 501(c)(3) of the Internal Revue Code and/or an instrumentality of a local government.

Section 7. <u>Fiscal Year</u>. The fiscal or business year of the Corporation shall be July 1 through June 30.

#### **ARTICLE VIII**

#### Amendments

Section 1. <u>Amendment</u>. New bylaws may be adopted, or these Bylaws may be amended, modified or repealed by the Board of Directors of the Corporation; provided, however, that any amendment shall be consistent with the terms set forth in the Agreement between the Corporation and the Florida Department of Education Division of Early Learning. All amendments to the Articles of Incorporation and/or Bylaws will be noticed to the Florida Department of Education Division of Early Learning as an amendment to the Coalition's Plan.

Section 2. <u>Record of Amendments</u>. Any amendment or alteration in these Bylaws shall be forthwith filed with the original Bylaws of the Corporation.

**SCOPE OF SERVICES.** Under the proposed agreement, Corporate Counsel will provide the following services on a fee for service arrangement:

- 1. Provide guidance and legal advice on the Sunshine Law, the Freedom of Information Act, Robert's Rules of Order, and Board rules and procedures;
- 2. Assists Board of Directors and employees to understand the legal roles and duties of their respective offices and interrelationships with others;
- Assists the Board of Directors to maintain awareness of ethical standards and appearance of fairness standards, and to avoid potential conflicts of interest, prohibited transactions and the appearance of prohibited transactions;
- 4. Appears before courts and administrative agencies to represent the Coalition's interests;
- 5. Works cooperatively with any special legal counsel retained by the Coalition for special projects. Coordinates with other special counsel, as needed, to assure proper management of legal issues, and proper coordination and transition of legal information among special counsel;
- 6. Attends Board and Committee meetings as required. Attends all Provider review hearings;
- 7. Answers requests for legal opinions, in writing and verbally. Prepares written legal opinions at the request of the CEO or the Board of Directors. Availability to answer staff questions by telephone, cell phone, email, or other electronic means;
- 8. Performs other legal services and tasks, as requested.

#### III. GENERAL SPECIFICATIONS

The following provisions will also apply.

- 1. Timeliness of response and accessibility to Corporate Counsel is an important aspect of this service. Accessibility includes the ability to be generally available to attend meetings in person on short notice and the ability to be reached promptly by telephone, cell phone, e-mail, or other electronic means.
- 2. Corporate attorneys must be available by phone, cell phone, e-mail, or other electronic means.
- 3. Service response is also of high importance. When the Coalition requests legal services, Corporate Counsel should provide some estimated time of completion and keep the requesting party apprised of any delays or special considerations.

#### IV. CONTRACT ETHICS

- No employee of the Coalition who exercises any responsibilities in the review, approval, or implementation of the proposal or contract shall participate in any decisions, which affects his or her direct or indirect personal or financial interest.

It is a breach of ethical standards for any person to offer, give or agree to give any Coalition employee, Board of Director, or for any Coalition employee, or Board of Director to solicit, demand, accept, or agree to accept from another person or firm, a gratuity or an offer of employment whenever a reasonably prudent person would conclude that such consideration was motivated by an individual, group or corporate desire to obtain special, preferential, or more favorable treatment than is normally accorded to the general public.

#### NARRATIVE:

Earlier this year, the Division of Early Learning (DEL) reviewed the workweek hours across all Coalitions and discovered inconsistencies. As a result, all Coalitions were required to have a 40-hour workweek. During this same analysis, DEL discovered additional inconsistencies regarding observed holidays.

In order for employees to be paid for observed holidays with approved funding, Coalitions must follow the State Approved Holidays:

- 1. New Year's Day
- 2. Dr. Martin Luther King Jr. Birthday
- 3. Memorial Day
- 4. July 4<sup>th</sup>
- 5. Labor Day
- 6. Veterans Day
- 7. Thanksgiving Day
- 8. Day after Thanksgiving
- 9. Christmas Day
- 10. Floating Holiday (employee choice)

The ELCHC will continue to observe ten (10) holidays. The impact is we gain Veterans' Day and a Floating Holiday while Christmas Eve Day and New Year's Eve Day are no longer observed.

These increases target the toddler, 3, 4, and 5-year-old care classes totaling a cost of \$5.8 M annualized if fully adopted by all providers.

# PROVIDER RATE INCREASE

Updated on October 13, 2021

## **Executive Summary**

On October 4, 2021, the Finance Committee reviewed and approved recommending to the full Board a provider rate increase for toddlers, 3, 4, and 5-year olds to the 66% percentile, costing approximately \$4.1 million for a full year.

Since then, we have two updates. First, ELCHC received a large \$14.2 million wait list Notice of Award for FY22, 3.5 times the amount received in FY21. This allocation was based on the ELCHC's relative wait list as of 6/30/2021 compared to the other coalitions but was overestimated. We will under spend this allocation by a few million dollars.

Second, DEL strongly advised each coalition to not underspend their SR funding, as DEL unfortunately had to deobligate \$30 million in total back to the feds in FY21. They also confirmed that SR funding is fungible, and that coalitions should make spending plans that encompass the entirety of their base funding, provider rate increase funding, and wait list funding.

As a result, ELCHC leadership is revising its recommendation for a larger provider rate increase to 100% of the 75% percentile calculated by DEL in 2019 for toddlers and 90% of 75<sup>th</sup> percentile of the 3, 4, and 5-year olds. This larger rate increase costs approximately \$5.8 million for a full year. We had a preliminary conversation with DEL on October 13, 2021 confirming the soundness of our approach and are working with DEL on their formal process for their review and approval, to be submitted after the ELCHC Board review.



# **EVALUATION OF DIRECT ENHANCEMENT SERVICES**

# **COVID-19 Impacts & Response**

COVID-19 continued to challenge the state and our area throughout 2020 and 2021. The majority of the Coalition's 100+ employees continued to participate in work from home without a disruption of services to families and providers.

Professional development continued in a virtual format and the ELCHC conducted live webinars monthly to support the provider community as the CARES funding applications rolled out. CARES funding was designed to support providers experiencing a loss of income due to low enrollment and rising costs of goods during the pandemic. Phase 1-5 grants were paid to providers per the requirements established by the Division of Early Learning.

The Coalition received more than 2,117 applications for phased grant funding to contracted and non-contracted providers and distributed more than \$10.9M to providers in fiscal 20-21. This phased grant funding was on top of \$3.6M in phased grant funding to providers in fiscal 19-20.

## **Comprehensive Consumer Education**

Parents who want or need child care are faced with the challenging task of searching for quality services within a program that is also convenient, affordable, and aligns with their goals for their child's educational attainment. In response, Early Learning Coalition of Hillsborough County's (ELCHC) Family Services team has developed a holistic approach to delivering a variety of strategies and resources to support parents seeking the right place for their child. The ELCHC's Family Services Specialists are trained as Child Care Resource and Referral (CCR&R) Specialists and offer unbiased information and guidance to families about child care options, information to help families identify quality early learning programs, financial assistance strategies and referrals to other community programs and resources as needed. CCR&R is a free service for all families in Hillsborough County.

In fiscal year 2020-2021, the majority of ELCHC Family Services team was successfully working from home to ensure families have the technical assistance needed to complete the online School Readiness (SR) and/or Voluntary Prekindergarten (VPK) application process. In addition, the ELCHC has partnered with seven Children's Board of Hillsborough County Family Resource Centers, which remained open during COVID-19, to ensure families in all areas of Hillsborough County can easily access technology. In addition to supporting the School Readiness and VPK application processes, the ELCHC maintains a comprehensive database of child care providers throughout Hillsborough County, including licensed child care centers and family child care homes as well as license-exempt facilities. CCR&R Specialists use this data to create customized lists of facilities for families seeking child care.

# During FY 20-21, the ELCHC:

• Responded to more than 85,045 phone calls from Hillsborough County families interested in School Readiness, VPK and/or additional resources for young children.

The 2020-2021 fiscal year proved an opportunity for the ELCHC to leverage one of its Core Values, innovation, as nearly all in person events were cancelled due to the COVID-19 pandemic, providing parents of young children with information about CCR&R and child care financial assistance programs. how to locate quality early learning environments, the importance of early literacy programs and ageappropriate milestones was still a priority. To promote awareness for services, ELCHC team members pivoted to virtual or drive through distribution of materials for families. In November 2020, the ELCHC partnered with Feeding Tampa Bay to bring a mobile pantry to the centrally located ELCHC offices and distributed books and other consumer education materials to families. ELCHC staff also conducted monthly parent engagement sessions in a series called Five For Five, which shares at home activities to develop the five stages of development in children before age 5. In December 2020, the ELCHC hosted a community outreach event sponsored by local funding to distribute developmentally age appropriate quality toys and learning resources to families during the holidays. In February 2021, Tampa Bay hosted Super Bowl LV (55). The ELCHC played a role in representing the importance of early learning as a pillar of the community impact from the Super Bowl. By May 2021, smaller, outdoor events had returned despite COVID-19 vaccination availability, the ELCHC returned to in person events, partnering with Hillsborough County School District Board Member, Stacy Hahn in her Early Literacy Campaign by distributing materials to families in a drive through event and sharing quality literacy opportunities virtually.



# **Provider Financial Supports**

The ELCHC continues to incentivize and motivate School Readiness providers to successfully adhere to School Readiness state requirements for child care performance standards, implement developmentally- appropriate curricula and related classroom resources that support curricula, provide literacy supports and professional development opportunities which improve the overall consistency and quality of School Readiness programs throughout Hillsborough County.

Fiscal year 2020-2021 presented a new opportunity for the ELCHC to support providers facing new challenges in early learning classrooms in our community. Early in the fiscal year, broken supply chains prevented many programs from obtaining the necessary supplies required to operate their programs during the COVID-19 pandemic. Led by the ELCHC Board of Directors, a supply drive to get medical grade infrared thermometers, hand sanitizer, cleaning spray, face masks and other essential items was conducted. More than \$89,000 was raised and in early August 2020, 600 programs in Hillsborough County received necessary supplies in a drive through event designed to celebrate the work of early learning professionals and program owners.

During the 2020-2021 fiscal year, the Hillsborough Infant & Toddler Initiative provided support to school readiness program providers to expand both the offering and quality of infant and toddler slots in their programs. This was accomplished by delivering developmentally appropriate classroom resource and materials to create and enhance classroom environments and provide professional development, stipends and reimbursements of training to early education teacher in classrooms for children birth to 36 months. The total investment in this program was \$99,456.

T.E.A.C.H. (Teacher Education and Compensation Helps) provides scholarships for early childhood teachers and facility/family home directors to work toward earning an Associate, Bachelor's or Master's degree in early childhood education, a Florida Staff Credential, a Director Credential, a National CDA Assessment, or credential renewals. The ELCHC supports T.E.A.C.H. scholar participants with technology to overcome barriers to pursuing advanced education. In FY 2020-2021, 133 participated in the program.

The Child Care INCENTIVE\$® FLORIDA Project is designed to increase stability and improve child care quality by reducing turnover and encouraging continued education of early childhood educators working in child care centers or family child care homes. This program provides education based salary supplements for low to moderate wage earners who work with young children, ages birth to 5, in School Readiness contracted sites. FY 2020-2021 marked the third year of participating in the program. During this fiscal year, 696 teachers participated, with \$471,006 distributed. Early childhood educators working directly with children for at least 20 hours per week, earning less than \$25 per hour, may be eligible for a salary supplement if they have some formal child care training and/or education beyond a high school diploma. The Children's Forum is the licensee for Child Care INCENTIVE\$ Florida and administers this program in participating counties in partnership with local funders.

## **Training**

During the course of the program year, 5603 practitioners were trained or participated in informational sessions. This resulted in many School Readiness providers achieving significant quality improvement. The ELCHC added Frameworks to our collective training partners, to offer an extensive list of learning events available to our School Readiness and VPK programs. Together with Champions for Children, Early Childhood Council of Hillsborough County, University of South Florida Program-Wide Behavioral Support, and WEDU, there were 86 virtual training and learning events available to our provider community.

ELCHC hosted our 2nd Early Childhood Conference on May 21, 2021, called "Teacher's Night Out". Teacher's Night Out was specifically designed to reinvigorate and reward early educators for their dedication to the field. Early childhood professionals had an opportunity to gather with others safely and carefully, listen to hand-selected, informational speakers and spend an evening networking. Selected developmentally appropriate materials were given to providers to support learning in the classroom, and QR codes with links directly to lesson plans were available to connect those materials to resources. There were approximately 300 in attendance including, teachers, directors, staff, community partners and ELCHC board members.

# **Coaching and Technical Assistance**

Coalition staff provided technical assistance and coaching through several initiatives including School Readiness Quality Improvement Plans, the Hillsborough Early Learning Network (HELN) in partnership with the University of Florida Lastinger Center, and the Hillsborough Infant Toddler Initiative. Much of the coaching remained virtual throughout 2020-2021 as the COVID-19 pandemic persisted. Hillsborough County providers on a Quality Improvement Plan received a total of 1,396 hours of coaching and 120 hours of Technical Assistance during the 2020-2021 fiscal year. Through HELN, staff of the ELCHC provided 353 hours of coaching and 9 hours of Technical Assistance to participants of the program. Early care providers participating in the Hillsborough Infant Toddler Initiative received 8 hours of coaching and 3 hours of Technical Assistance.

# **Monitoring**

The ELCHC Provider Relations team conducts monitoring of contracted School Readiness and Voluntary Prekindergarten (VPK) programs to ensure contract compliance. Consequences for noncompliance are determined in accordance with state rule and law, and the ELCHC's Progressive Enforcement Procedures.

Due to the COVID-19 pandemic, the team conducted the 2020-2021 monitoring remotely instead of at child care providers' physical location. For Voluntary Prekindergarten Program (VPK): ELCHC staff monitored 130 VPK Programs to ensure each provider's program met the terms and conditions of the State of Florida Statewide Voluntary Prekindergarten Provider Contract. ELCHC staff monitored private providers; Hillsborough County Public Schools (HCPS) conducted the monitoring of HCPS Voluntary Prekindergarten schools. School Readiness Program (SR): ELCHC staff performed desk reviews (Tier 1) of 745 School Readiness Program providers in accordance with state requirements. The desk review analyzes if providers have met the several components of the School Readiness Provider Contract. In addition, staff remotely monitored a sample of 129 contracted School Readiness program providers using the Statewide Provider Monitoring Tool for Tier 2 compliance. These providers were both randomly selected and providers who were considered high risk due to the results of a previous monitoring.



#### **Inclusion**

The Early Childhood Council of Hillsborough County (ECC) provides inclusion support services to providers and families in Hillsborough County. The local Warm Line is available to all child care centers, family child care homes and parents who request assistance regarding child care arrangements or concerns for their children with special needs. The goals of the Inclusion Initiative at the ELCHC are:

- 1. To increase the number of providers who offer quality inclusive programs for children with disabilities and special health care needs.
- 2. To enhance the confidence, ability level, and education of caregivers who care for children with disabilities and special health care needs.
  - Training workshops provided: 8
  - Trainings offered through the Early Learning Coalition: 3
- 3. To assess the developmental progress of children and communicate this information to their caregivers to ensure all children receive quality services and referrals to additional services as needed.
  - Number of children screened using the Ages and Stages Questionnaire: 10076
  - Number of Developmental Activities issued: 2,135
  - Number of Level II Developmental Screening: 135
  - Number of referrals to Early Steps: 136
  - Number of Developmental Evaluations through HCPS: 108
- 4. To assist providers and the families they serve in understanding and accessing the community resources and services available for children with disabilities and special health care needs.
- 5. To increase community awareness of the need for requirements of, and benefits associated with inclusive child care for children with disabilities and special health care needs.
- 6. ECC Inclusion Services Program offers trainings on a variety of issues, including health, child development, environmental adaptions, curriculum, and laws and regulations. During FY 20-21, ECC reports the following activities:
  - Number of trainings offered: 11
  - Number of training hours: 32
  - Number of practitioners trained: 170
  - Number of Warm Line calls: 66
  - Number of early learning settings that received technical assistance and consultation: 41
  - Number of technical assistance and consultation hours provided: 489



# **Quality Activities for Infant & Toddler Care**

The Hillsborough Infant & Toddler Initiative, an ELCHC led program, provides resources to strengthen the quality of infant and toddler care in Hillsborough County. Participating childcare programs have access to coaching, technical assistance, professional development, and classroom materials. The focus of the Initiative is to encourage providers to serve more infant and toddlers while enhancing the quality of care within these programs. During the 2020-2021 fiscal year the Hillsborough Infant & Toddler Initiative was comprised of two sub-programs one solely sponsored by ELC School Readiness funds to target high-needs zip codes located predominately in the city of Tampa and a second funded by a grant from Hillsborough County Affordable Housing Services that targeted unincorporated Hillsborough County which included zip codes outside of the City of Tampa.

The 2020-2021 fiscal year marked the second year of the Initiative's focus on providing coaching, technical assistance, program improvements, professional development opportunities for teachers and directors, classroom materials for indoor and outdoor experiences for infants and toddlers, increase families access to quality infant/toddler care by creating more slots within those programs for children birth to 36 months and increase family knowledge of infant/toddler development by conducting family engagement activities and the opportunity to participate in the "Anytime is 3T's Time", a project supported by PNC Bank, to improve parents awareness of strategies to foster their child's learning through ordinary daily interactions at home.



# **ATTACHMENT A - Trainings By Topic Area**

#### **Technical Assistance**

#### Early Learning Standards

#### Integrating the Standards: Phonological Awareness

This 2-hour instructor-led training is designed for VPK instructors and directors. With a focus on the key elements of early language and literacy development, participants will gain an understanding of what phonological awareness is and how it connects to reading and writing. Through demonstration and experiencing activities and materials that can be used in the classroom, learners will move through the step-by-step progression of how children acquire phonological awareness and gain practical information about how to plan activities and implement phonological awareness in the preschool classroom.

## Math 1: Making Sense of Sets and Numbers

This 3-hour instructor-led training is designed for VPK instructors and directors but is suitable for teachers of preschool-age children. Participants will gain early math knowledge and practical information about how to structure the classroom environment and plan activities to integrate math concepts and skills throughout the learning day. The training focuses on using attributes to sort and compare sets, as well as exploring quantities, numerosity, subitizing and cardinal numbers.

#### *Math 2: Counting and Operating with Numbers*

This 3-hour instructor-led training is designed for VPK instructors and directors but is also suitable for teachers of preschool-age children. Participants will gain early math knowledge and practical information about how to structure the classroom environment and plan activities to integrate math concepts and skills throughout the learning day. The training focuses on the big ideas of counting and number operations such as the principles of counting, common counting errors and strategies for helping children rectify these errors, adding, subtracting, and subitizing.

#### Math 3: Patterns, Measurement and Data

This 3-hour instructor-led training is designed for VPK instructors and directors but is suitable for teachers of Preschool-age children. Participants will gain early math knowledge and practical information about how to structure the classroom environment and plan activities to integrate math concepts and skills throughout the learning day. The training focuses on using the classroom to explore patterning, using different attributes in measurement (such as length, capacity, circumference, quantifying and direct & indirect comparisons), and answering authentic questions through representing, collecting and interpreting data.

#### Math 4: Shapes and Spatial Relationships

This 3-hour instructor-led training is designed for VPK instructors and directors but is suitable for teachers of Preschool-age children. Participants will gain early math knowledge and practical information about how to structure the classroom environment and plan activities to integrate math concepts and skills throughout the learning day. The training focuses on developmentally appropriate experiences for exploring geometry and spatial relationships with young children, such as defining and analyzing 1-, 2- and 3-dimentional shapes and symmetry, and perspective-taking and visualizing space.

#### VPK Assessment Instructional Implications

This professional development is appropriate for VPK directors, administrators, and teachers who have administered the VPK Assessment. Participants will review the VPK Assessment Online Reporting System score types, reports, and instructional resources for planning instruction based on VPK Assessment data.

## **Child Screening and Assessment**

#### Child Assessment Orientation: What Now?

This orientation is for those who are currently participating in child assessment and will discuss expectations connected to child assessment. The expectations include roster information, assessment tool reliability, benchmark dates, how to document completion and technical assistance. This training will look at curriculum for infants and toddlers and the importance of individualized programming. Practitioners will explore curriculum within the context of relationships and the importance of observing children for individualization.

#### Ages and Stages Questionnaire 3rd edition (ASQ-3)

This learning event is designed for teachers, directors and childcare providers who are implementing early care and education for Infant, Toddler and Preschool children. This event will assist with understanding the background and development of the ASQ-3 and it will provide the most recently designed training in administering, scoring and discussing the results of the questionnaire with families and appropriate agencies. Participants will leave this learning event ready to accurately administer, score and sensitively discuss the results of the ASQ-3.

#### Ages and Stages Questionnaire Social Emotional 2nd Edition

This learning event is designed for teachers and directors who are providing early care and education for preschool children, particularly those with social emotional concerns. This learning event will help you administer, score and discuss results of the questionnaire with families. This event will also address effective strategies that promote positive social and emotional development. The ASQ SE 2 training supports the CLASS Domains by providing insight into the social emotional needs of young children. The assessment and follow-up knowledge addressed in this training support the provision of emotional support that is a key in being able to function in a classroom environment.

#### Observation, Documentation and Assessment in Early Childhood Classrooms

This learning event will provide information on writing purposeful, objective observations of children. Participants will have many opportunities to distinguish between subjective and objective observations and writing factual, purposeful observations.
