Katie Looney v. Early Learning Coalition of the Emerald Coast. Katie Looney is a former employee of Early Learning Coalition of the Emerald Coast ("Emerald Coast"). On May 6, 2021, Ms. Looney filed a Charge of Discrimination with the Florida Commission on Human Relations ("FCHR"). She alleged that Emerald Coast discriminated against certain employees in violation of the Florida Civil Rights Act, Title VII of the Civil Rights Act of 1964, the Age Discrimination in Employment Act, and the Americans with Disabilities Act, and retaliated against Ms. Looney for speaking out about the alleged mistreatment of the employees based on their race or disability. Emerald Coast filed a position statement denying the allegations in the Charge. The FCHR issued a Notice of Termination on November 2, 2021, in which the agency found no reasonable cause that an unlawful practice occurred. Ms. Looney has until December 7, 2021 to file a Petition for Relief.

## 4. PRICE

The Coalition has requested a monthly flat fee that would be charged to advise on routine matters that could be handled over the phone or otherwise without extensive research or other legal work.
